Overview

Alaina is recognised as a leading senior junior regularly appearing as sole counsel or as part of a team in the High Court and Court of Appeal as well as UK tribunals (including the UKIPO) and in arbitration.

Regularly representing clients across a range of industries including fashion, media, pharmaceutical, retail, sports and tech, Alaina's practice focuses on intellectual property law as well as high profile and substantial commercial and competition related disputes on a range of issues including crypto, database rights, software licenses, data protection, breach of confidence / confidential information, distribution agreements and damages.

Before coming to the bar, Alaina practised as a litigation solicitor in Australia (Blake Dawson Waldron, now Ashurst LLP) and in the UK (Freshfields Bruckhaus Deringer and TSol). She qualified as a barrister and solicitor in Western Australia in 2006.

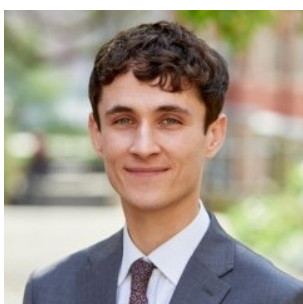
