## Overview

Emma Jones is a leading junior with a broad practice encompassing all aspects of commercial litigation, arbitration and advisory work. 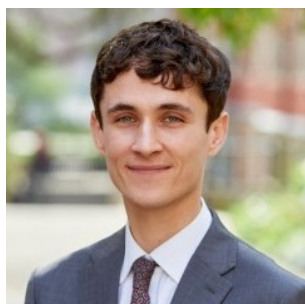
