## Overview

Acting (with Alex Gunning KC) in defence of an arbitration appeal under s.68 and s.69 of the Arbitration Act.
- **UNCITRAL Proceedings**  
For a Defendant (with Michael Sullivan QC and Hannah Brown QC) in a shareholder dispute in a large mining company.

Appearing (with Michael Fealy KC) in defence of a claim for an anti-suit injunction, in the context of various insurance-related international proceedings following the collapse of the Greensill group. Successfully resisted the continuation of the majority of the interim anti-suit injunction in [2024] EWHC 3068 (Comm).

Appeared (unled) in respect of matters arising following the dismissal of one of the largest pieces of litigation in English history.
- **Carnival v Maleth**  
Appearing (with Hannah Brown KC) in defence of a complex claim relating to payments due under an air charter agreement.
- **Stonegate Farmers Ltd and Others v Michael Kent and Others**  
Acting (with David Cavender KC and Joyce Arnold) for the First Defendant in a claim relating to alleged breach of duties following the divestiture of a large egg company.

For a major international airline (with Jon Turner QC, Conall Patton QC and Michael Armitage), in Chancery Division proceedings defending substantial economic tort and follow-on competition law claims brought by over 500 claimants. Successfully applied to strike out a large part of this claim in [2015] EWCA Civ 1024.
- **Bao Xiang International Garment Centre & Anr v. BA Plc [2015] EWHC 3071**  
For a major international airline (with Ken MacLean QC), in a successful application to strike out a claim brought by approximately 65,000 Chinese claimants. The claim was struck out for want of authority and/or as an abuse of process.
- **ITV Services Ltd v. HMRC [2013] EWCA Civ 867; [2013] BTC 633; [2013] STI 2563**  
For HMRC (with Malcolm Gammie QC) in Court of Appeal proceedings concerning the construction (and tax consequences) of various clauses in a number of actors' contracts.
- **Adept Care & Education Ltd v. Clark**  
For Claimant company (with Ben Strong) in Mercantile Court proceedings, which ultimately settled, arising out of alleged breaches of an exclusivity clause in Heads of Terms for a proposed acquisition.

insurance syndicate.
