Commercial Dispute Resolution & Arbitration

- **LCIA Arbitration**
Acting for the Respondent (led Alexander Brown KC) in arbitral proceedings concerning contracts for the construction of a production plant. The claims concern unpaid invoices of nearly €10 million, with counterclaims exceeding €12 million for delay liquidated damages, breaches of safety obligations, and other contractual shortcomings.
- **ICC Arbitration**
Assisting Alexander Gunning KC and Jarret Huang (during pupillage) in an oil and gas dispute involving international sanctions and contractual termination rights.
- **LCIA Arbitration**

Competition
