Overview

Sandy Phipps is a leading senior junior with a broad, multi-jurisdictional practice. He has been described as one of the “stars of his generation” (Chambers and Partners) and a “future leader of the Commercial Bar” (Legal 500).

Sandy’s speciality is complex commercial disputes, often with an international dimension. He has appeared in or advised on disputes at all levels of the English courts, as well as disputes in arbitration and in foreign courts (including the courts of the Cayman Islands, the BVI, France, Saudi Arabia, Hong Kong, the United States and Australia).

Sandy also has extensive experience of advising clients in connection with disputes in other forums, including internal investigations, regulatory or law enforcement investigations (including by the Financial Conduct Authority, the Serious Fraud Office, and the United States Department of Justice), and Parliamentary and other public inquiries.

Alongside his practice, Sandy maintains an active interest in academic law. He has published in areas including banking law, contract, jurisdiction and civil procedure. He is a regular contributor to, and sits on the editorial board of, the *Journal of International Banking & Financial Law* and writes the chapter on guarantees in *Paget’s Law of Banking*.

During his career Sandy has been nominated for or received various accolades for his work. Most recently, in 2024 Sandy was awarded both Banking & Finance Junior of the Year by Chambers & Partners and Financial Services & Insurance Junior of the Year by Legal 500; and in 2025 he was re-nominated for the same award by Legal 500.

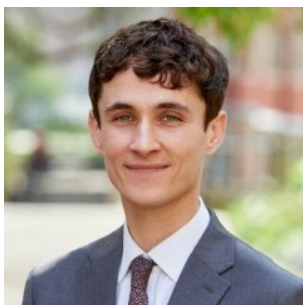
