## Overview

*Simon Gilson's practice spans a broad spectrum of commercial work including in the areas of banking and finance, civil fraud, energy and natural resources and professional liability. He primarily acts as senior junior counsel in legal teams conducting complex, high-value litigation in the English courts and offshore common-law jurisdictions and international arbitration under various institutional rules or ad hoc. As sole counsel, he advises individuals and companies in relation to a wide range of commercial and company disputes and he regularly appears as an advocate in his own right.*
